## GUIDELINES / PROCEDURES FOR PROGRAM PARTICIPATION OF HOMESCHOOLED STUDENTS IN EXTRA-CURRICULAR ACTIVITIES

Homeschooled students will be permitted to participate in the South Eastern School District extra-curricular activities in accordance with Section 511 of the Pennsylvania School Code.

### ELIGIBILITY

Homeschooled students electing to participate in extra-curricular activities (grades 7-12) are required to meet the same standards of eligibility required of South Eastern School District students. For those students wishing to participate in extra-curricular activities, they must notify the High School Assistant Principal 20 days in advance of the activity. This time is necessary to ensure proper documentation verifying completion of the eligibility requirements listed below. To maintain eligibility, the home-schooling supervisor is required to submit to the High School Assistant Principal a weekly letter stating that the Home-Schooled student (grade 9-12) has maintained a 60% average in courses and is passing five (5) credits and is not failing more than one (1) credit. A student in grade 7-9 must maintain a 60% average in courses and be passing four (4) credits and not failing more than one (1) credit. The approved form must be delivered by the Home School Supervisor to the High School Assistant Principal before 2:40 p.m. on Thursday afternoon or the home-schooled student will not be eligible for continuation of practice or participation until the next scheduled opportunity to submit verification. A week shall be defined as Sunday through Saturday.

Should a student withdraw from the South Eastern School District during the academic year to be home-schooled, the student shall be ineligible to participate in extra-curricular activities for 45 school days. Said "school year" shall be defined as beginning the first officially sanctioned day of practice as defined by PIAA and concluding June 30th.

### THE HOMESCHOOLED STUDENT IS RESPONSIBLE FOR THE FOLLOWING:

- Attain a physical examination as required by the School District.
- Complete all required PIAA/YAIAA forms and certificates.
- Provide transportation to and from all practices/home games/rehearsals/etc. If the home school student will be driving to the activity/practice his/herself, they must receive a driving permit from the High School office. All athletes/students are required to travel with the team or group to away competitions or activities.
- Follow all rules/regulations as required of South Eastern students.
- Sign the student/parent signature page in the Student/Parent Athletic Handbook, Code of Conduct forms and other forms, as appropriate.
- Complete the athletic information card, the coach's emergency card and/or a school emergency card, and the home school eligibility requirements.

Each request for participation in an extra-curricular activity will be reviewed by the High School Principal, the Coach/Advisor of the Fall/Winter/Spring activity and approved by the Superintendent.
